I Dibyendu Kumar Panda, Lecturer Rourkela Law College I am submitting the following report on Proctorial system.

- 1. I have taken all possible steps to contact the students and I could be able to contact 70 students and rest of the students could not be contacted due to telephonic problem such as lack of network and in non reachable area.
- 2. out of the 81 number of students whom I contacted their response is all together positive although it seems to me that there is some negative thought among themselves and I have sincerely trying to convince those students to be responsive in attending classes so good behavior to the teachers and maintain friendly relation among themselves and in this respect I am quite affirmative.
- 3. While contacting the students it has come to my notice that some of the students are outsiders elsewhere and attending the classes and for this reason their showing negative attitude.
- 4. The telephone number given by the students and proctor are not found out a times and there is a gap of communication in contacting them in over telephone.
- 5.The possible reason is that out of the 81 number of students some of them are outsiders and some of them are housewife. The other reason is that the first part of the study describe the development of a self report measures of reason for missing classes. Reasons included not being the mood , personal issues. Health issues, and no negative consequences. Results show that personality treats especially conscientiousness.
- 6. At the end of the above paras my suggestion has following strategies to improve student's attendance of classroom.
- A. Link attendance with the grades. College management should link the attendance percentage directly to the students overall grades. B. Then the management should try to establish a friendly atmosphere with in the institution which will attract the students. It will help to regularize the irregular students

During the interaction process I tried to convey them various career possibilities which can be achieved by attending regular classes which may change the mindset of the students.
- 6. That after the above evaluation I found that the problem of students not involving with classes and the college expectedly can be overcome by adopting different motivating initiatives. Some of my suggestion to this problems are as follows:-
  - > To conduct various extra-curriculum and cultural activities which will boost the interest of the students towards the college.
  - > To commence the spoken English and personality development course as soon as possible.
  - To organize class seminar, debate, penal discussions, legal quiz, moot courts etc. to make the teaching and learning process more interesting.
  - To make Alumni association functional which will motivate and inspire the current students.
  - > To create different Volunteer Groups and motivate them to organize various awareness camps, visit to unprivileged and other volunteer activities.


 The Human Rights Day was observed on 10.12.2020 at 10.30am through video conferencing with Taluk Legal Service Committee (google meet).

 Sri Rajat Ku. Panda (JMFC) Civil Judge Senior Dev discussed about the property Rights of Womens.


Rural JMFC Sidharth Shankar Senapati discussed about the Domestic Violence, Sexual Harassment on Women and the protection Laws available for the women.

Dr. Sampadika Mohanty Asst. Prof. in Law invited the Guests and Hosted the above meeting.




 To acquaint the participants with basics of intellectual property rights and patent filing.






