
 The Human Rights Day was observed on 10.12.2020 at 10.30am through video conferencing with Taluk Legal Service Committee (google meet).

Sri Rajat Ku. Panda (JMFC) Civil Judge Senior Dev discussed about the property Rights of Womens.


Rural JMFC Sidharth Shankar Senapati discussed about the Domestic Violence, Sexual Harassment on Women and the protection Laws available for the women.

In the 27th meeting of the Odisha State Legal Services Authority the following resolution was passed with regard to the opening of Legal Services Clinics in Law Colleges:

"Resolved that Legal Aid Clinics be established in Law Colleges of the State and law students may be involved in Legal Services activities"

In the context, Hon'ble the Executive Chairperson of this Authority has been pleased to issue the following directions/guidelines for establishment of Legal Aid Clinics in Law Colleges/Law Universities in your district:

- Universities under their jurisdiction and take up the matter with the Principal/Vice-Chancellor/Director, as the case may be, of the concerned institution for establishment of Legal Aid Clinics in the said institution as per Regulation-24 of Legal Services Authorities (Legal Aid Clinics) Regulations 2011.
- As regard to the accommodation and furniture for functioning of such Clinics, the concerned institution may be requested to facilitate the same. The Legal Aid Clinic shall have at least the basic and essential furniture like a Table and 5-6 Chairs. There shall be a Sign Board both in English and Odia depicting the Legal Aid Clinics, working hour and the days on which the Legal Aid Clinic shall remain open.
- The District Legal Services Authority shall render the required technical assistance for the operation of such Legal Aid Clinics and shall take measures to promote the activities of such Legal Aid Clinics. Trained Para Legal Volunteers may be deputed to the Legal Aid Clinics established under Regulation-24, on call for assisting the persons seeking free legal services and for interacting with the students and the members of the faculty. Services of a Linever can also be made available to the Clinic on call in consultation with the Secretary of the DLSA.

- They also took the initiative to encourage the senior for COVID-19 vaccination.



- Finally the programme was winded up and vote of thanks was addressed by our Principal Sir Dr. D.Behera.




