1. The College offers 3 Years Bachelor of Law course (CBCS system).
2. A candidate is eligible to apply for admission into three years LL.B. Degree course after obtaining the Bachelor Degree from a recognized University which are prescribed by various University and recognized by Madhusudan Law University as well.
3. Candidates belong to General category must have secured a minimum of 45% of marks in aggregate. SC/ST candidates are to secure a minimum of 40% marks in graduation. Seats are reserved for SC/ST candidates as per Govt. of Odisha guidelines.
4. Students seeking admission should apply in the prescribed application form within the stipulated last date fixed by Madhusudan Law University or Govt. of Odisha. Application form can be obtained from the college office on payment of **Rs.500/- Rupees (Five Hundred) only** or by Regd. Post on remittance of **Rs. 800/- Rupees (Eight Hundred) only** by Demand Draft in favour of Principal, Rourkela Law College, Nayabazar, Rourkela-769010 or download from the college website www.rourkelalawcollege.in and submit along with a demand Draft of **Rs. 500/-Rupees (Five Hundred) only**.
5. The application form duly filled along with the following self attested copies of documents must reach the Principal, Rourkela Law College, Rourkela-769010 on before the last date.
 - (a) Matriculation Certificate
 - (b) +2 Certificate
 - (c) +3 Degree Certificate or equivalent Certificate.
 - (d) +3 Mark sheet or equivalent Mark sheet.
 - (e) Caste Certificate in case of S.C. / S.T. candidates from competent authority.
6. Selected candidates shall produce the following documents at the time of admission:-
 - (a) Original College Leaving Certificate & Migration certificate (Compulsory).
 - (b) Conduct certificate in Original from the institution last attended or from a gazetted officer in case of private candidates. Private candidates are also to produce provisional certificate from their concerned university in lieu of College Leaving Certificate.
 - (c) University Mark Sheet of the qualifying degree examination in Original for verification.
 - (d) Three Passport size Photographs of the candidate duly attested.
 - (e) Original Caste Certificate in case of S.C. /S.T applicant for verification from competent authority.
 - (f) In case the candidate is in service, a letter of permission in original from the employer to the effect that he/she has been permitted to study in the College.
 - (g) Original Matriculation Certificate or equivalent for verification.
 - (h) Provisional Certificate/Degree of the qualifying Examination.
